


AN INTRODUCTION TO THE WORLD OF SHERLOCK HOLMES

HOLMES AND WATSON

First appearing in "A Study in Scarlet" in Beeton's Christmas Annual of 1887, Sherlock Holmes remains a remarkably vigorous and fascinating figure for a man of such advanced years. The detective's home and office at 221B Baker Street are shrines now, not simply rooms in which Holmes slept and deduced and fiddled with the violin when he could not quite discern the significance of a clue or put his finger on a criminal's twisted motive.

We know both a great deal and very little about Sherlock Holmes as a person. The son of a country squire (and grandson of the French artist Vernet's sister), Holmes seems to have drawn little attention to himself until his University days, where his extraordinary talents for applying logic, observation and deduction to solving petty mysteries earned him a reputation as something of a genius. Taking the next logical step, Holmes set up a private consulting detective service, probably in 1878. Four years later, he met and formed a partnership with a former military surgeon, Dr. John Watson. Four novels and fifty-six short stories tell us everything we know of the odd pair and their extraordinary adventures.

Less a well-rounded individual than a collection of contradictory and unusual traits, Holmes seldom exercised yet was a powerful man of exceptional

speed of foot. He would eagerly work for days on a case with no rest and little food, yet in periods of idleness would refuse to get out of bed for days. Perhaps his most telling comment appears in "The Adventure of the Mazarin Stone:"

I am a brain, Watson. The rest of me is a mere appendix.

Holmes cared little for abstract knowledge, once noting that it mattered not to him if the earth circled the sun or vice versa. Yet he could identify scores of types of tobacco ash or perfume by sight and odor, respectively. Criminals and their modus operandi obsessed him; he pored over London's sensational newspapers religiously.

A master of disguise, the detective successfully presented himself as an aged Italian priest, a drunken groom, and even an old woman! A flabbergasted Watson is the perfect foil to Holmes, who seems to take special delight in astonishing his stuffy if kind cohort.

In "The Sign of Four," Holmes briefly noted the qualities any good detective should possess in abundance (if possible, intuitively): heightened powers of observation and deduction, and a broad range of precise (and often unusual) knowledge. In this *Sherlock Holmes Solo Mysteries*TM adventure, you will have ample opportunity to test yourself in these areas, and through replaying the adventure, to improve your detective skills.

Although impressive in talent and dedication to his profession, Sherlock Holmes was by no means perfect. Outfoxed by Irene Adler, Holmes readily acknowledged defeat by “the woman” in “A Scandal in Bohemia.” In 1887, he admitted to Watson that three men had outwitted him (and Scotland Yard). The lesson Holmes himself drew from these failures was illuminating:

Perhaps when a man has special knowledge and special powers like my own, it rather encourages him to seek a complex explanation when a simpler one is at hand.

So learn to trust your own observations and deductions — when they make sense and match the physical evidence and the testimony of trusted individuals — don’t rush to judgment, and if you like and the adventure allows, consult Holmes or Watson for advice and assistance.

VICTORIAN LONDON

When Holmes lived and worked in London, from the early 1880’s until 1903, the Victorian Age was much more than a subject of study and amusement. Queen Victoria reigned over England for more than 60 years, an unheard of term of rule; her tastes and inhibitions mirrored and formed those of English society. Following the Industrial Revolution of roughly 1750-1850, England leaped and stumbled her way from a largely pastoral state into a powerful, flawed factory of a nation. (The novels of Charles Dickens dramatically depict this cruel, exhilarating period of sudden social change.) Abroad, imperialism planted the Union Jack (and

implanted English mores) in Africa, India, and the Far East, including Afghanistan, where Dr. Watson served and was wounded.

Cosmopolitan and yet reserved, London in the late Nineteenth Century sported over six million inhabitants, many from all over the world; it boasted the high society of Park Lane yet harbored a seedy Chinatown where opium could be purchased and consumed like tea. To orient yourself, consult the two-page map of London on pages 10 and 11. You will see that Baker Street is located just south of Regent’s Park, near the Zoological Gardens, in the heart of the stylish West End of the city. Railway and horse-drawn carriages were the preferred means of transport; people often walked, and thieves frequently ran to get from one place to another.

THE GAME’S AFOOT!

Now, match wits with the world’s greatest consulting detective. And have no fear — if you don’t completely succeed at first, just play again! It might be wise to keep in mind Holmes’ advice to Watson and all would-be detectives:

“It is an old maxim of mine,” he said, “that when you have eliminated the impossible, whatever remains, however improbable, must be the truth.”



THE SHERLOCK HOLMES SOLO MYSTERIES™ GAME SYSTEM

THE GAMEBOOK

This gamebook describes hazards, situations, and locations that may be encountered during your adventures. As you read the text sections, you will be given choices as to what actions you may take. What text section you read will depend on the directions in the text and whether the actions you attempt succeed or fail.

Text sections are labeled with three-digit numbers (e.g., "365"). Read each text section only when told to do so by the text.



PICKING A NUMBER

Many times during your adventures in this gamebook you will need to pick a number (between 2 and 12). There are several ways to do this:

- 1) Turn to the Random Number Table at the end of this book, use a pencil (or pen or similar object), close your eyes, and touch the Random Number Table with the pencil. The number touched is the number which you have picked. If your pencil falls on a line, just repeat the process. or
- 2) Flip to a random page in the book and look at the small boxed number in the inside, bottom corner of the page. This number is the number which you have picked. or
- 3) If you have two six-sided dice, roll them. The result is the number which you have picked. (You can also roll one six-sided die twice and add the results.)

Often you will be instructed to pick a number and add a "bonus". When this happens, treat results of more than 12 as "12" and treat results of less than 2 as "2".

INFORMATION, CLUES, AND SOLVING THE MYSTERY

During play you will discover certain clues (e.g., a footprint, murder weapon, a newspaper article) and make certain decisions and deductions (e.g., you decide to follow someone, you deduce that the butler did it). Often the text will instruct you to do one of the following:

Check Clue xx or Check Decision xx or Check Deduction xx.

“xx” is a letter for Clues and a number for Decisions and Deductions. When this occurs, check the appropriate box on the “Clue Record Sheets” found at the beginning of the book. You should also record the information gained and note the text section number on the line next to the box. You may copy or photocopy these sheets for your own use.

Other useful information not requiring a “check” will also be included in the text. You may want to take other notes, so a “NOTES” space is provided at the bottom of your “Character Record”. Remember that some of the clues and information given may be meaningless or unimportant (i.e., red herrings).

EQUIPMENT AND MONEY

Whenever you acquire money and equipment, record them on your Character Record in the spaces provided. Pennies (1 Pence), shillings (12 pence), guineas (21 shillings), and pounds (20 shillings) are “money” and may be used during your adventures to pay for food, lodging, transport, bribes, etc. Certain equipment may affect your abilities as indicated by the text.

You begin the adventure with the money noted on the completed Character Record sheet near the front of the book.

CHOOSING A CHARACTER

There are two ways to choose a character:

- 1) You can use the completely created character provided at the beginning of the book. or
- 2) You can create your own character using the simple character development system included in the next section of this book.

STARTING TO PLAY

After reading the rules above and choosing a character to play, start your adventures by reading the Prologue found after the rules section. From this point on, read the passages as indicated by the text.

CREATING YOUR OWN CHARACTER

If you do not want to create your own character, use the pre-created character found in the front of this book. If you decide to create your own character, follow the directions given in this section. Keep track of your character on the blank Character Record found in the front of this book. It is advisable to enter information in pencil so that it can be erased and updated. If necessary, you may copy or photocopy this Character Record for your own use.

As you go through this character creation process, refer to the pre-created character in the front of the book as an example.

SKILLS

The following 6 "Skill Areas" affect your chances of accomplishing certain actions during your adventures.

- 1) **Athletics** (includes fitness, adroitness, fortitude, pugnacity, fisticuffs): This skill reflects your ability to perform actions and maneuvers requiring balance, coordination, speed, agility, and quickness. Such actions can include fighting, avoiding attacks, running, climbing, riding, swimming, etc.
- 2) **Artifice** (includes trickery, disguise, stealth, eavesdropping): Use this skill when trying to move without being seen or heard (i.e., sneaking), trying to steal something, picking a lock, escaping from bonds, disguising yourself, and many other similar activities.
- 3) **Intuition** (includes sensibility, insight, reasoning, deduction, luck): This skill reflects your ability to understand and correlate information, clues, etc. It also reflects your ability to make guesses and to have hunches.
- 4) **Communication** (includes interviewing, acting, mingling, negotiating, diplomacy): This skill reflects your ability to talk with, negotiate with, and gain information from people. It also reflects your "social graces" and social adaptivity, as well as your ability to act and to hide your own thoughts and feelings.

- 5) **Observation** (includes perception, alertness, empathy): This skill reflects how much information you gather through visual perception.
- 6) **Scholarship** (includes education, science, current events, languages): This skill reflects your training and aptitude with various studies and sciences: foreign languages, art, history, current events, chemistry, tobaccory, biology, etc.

SKILL BONUSES

For each of these skills, you will have a Skill Bonus that is used when you attempt certain actions. When the text instructs you to "add your bonus," it is referring to these Skill Bonuses. Keep in mind that these "bonuses" can be negative as well as positive.

When you start your character, you have six "+1 bonuses" to assign to your skills.

You may assign more than one "+1 bonuses" to a given skill, but no more than three to any one skill. Thus, two "+1 bonuses" assigned to a skill will be a "+2 bonus", and three "+1 bonuses" will be a "+3 bonus". Each of these bonuses should be recorded in the space next to the appropriate skill on your Character Record.

If you do not assign any "+1 bonuses" to a skill, you must record a "-2 bonus" in that space.

During play you may acquire equipment or injuries that may affect your bonuses. Record these modifications in the "Bonus" spaces.

Bobby Chambers: Servant at the "Three Continents" Club.

Lord Grayson: Son of the Earl of Waynesborough, Member of the "Three Continents."

Sir George Grant: Member of the "Three Continents."

Mycroft Holmes: Brother of the late Sherlock Holmes.

John Howard: Member of the "Three Continents."

Lord Howard: Member of the "Three Continents."

Edwin Johnson: Butler at the "Three Continents."

Captain Edward Lawrence: Army officer, member of the "Three Continents."

Alexander Lewis: Member of the "Three Continents."

Captain Sherwood Locke: Provost Officer, friend of Mycroft Holmes.

Thomas Martin: Member of the "Three Continents."

Christopher Marshall: Friend of Dr. Watson, member of the "Three Continents."

Inspector Alec McDonald: Scotland Yard officer assigned to the investigation.

Sir Terrence Milton, Baronet: Businessman, member of the "Three Continents"; murder victim.

Miss Ellen Phipps: Friend of Dr. Watson.

John Strickland: Chairman of the "Three Continents."

Thomas Sullivan: Member of the "Three Continents."

John Symington: London businessman.

Earl of Waynesborough: Member of the "Three Continents."

AN INTRODUCTORY NOTE

In this case the player-detective is a former Baker Street Irregular, who, inspired by Sherlock Holmes, acquired enough education to become a detective in a small way himself.

The case is set in early 1894. Two and a half years ago, the player read the shocking news of Sherlock Holmes' death in an accident in Switzerland, news confirmed recently when Dr. Watson published the story, "The Final Problem," which described the circumstances of Holmes' death. Though aware of his own inferior skills, the player tries to fight crime in London in the tradition of his great mentor.

You have a pocketknife, a notebook, a pencil, and thirty shillings and four pounds in cash. You may now begin your investigation. Enter these items on your Character Record. Good luck. The game is afoot.

PROLOGUE

Roaming London one brisk winter morning, you decide to stop at the store operated by Wiggins, former chief of the Baker Street Irregulars, and read the morning papers. Your old leader and friend greets you cheerfully, then points to a story headlined on several papers. At his urging you read several accounts of a murder in "The Three Continents Club." You see that Sir Terrence Milton, a noted businessman with "interests in many corners of the empire," was the victim. While no arrest has been made, Inspector Alec McDonald of Scotland Yard reports that, "The police are pursuing their inquiries carefully, and an arrest can be expected shortly, as soon as the police have verified all aspects of the case."

You sigh a little. "They would probably have the killer behind bars now, Wiggins," you say, "if Mr. Holmes was still with us in London."

"Perhaps," he answers, "and perhaps not. One of my mates on the force stopped by and told me something of the case. He said the evidence points like a knife straight at Dr. Watson, Mr. Holmes' old friend. In a case like that Mr. Holmes might not have wanted to find the proof to send his best mate for a date with Jack Ketch."

"Dr. Watson!" you say in astonishment. "How could anyone suspect him of committing a crime? He's a well-known writer and a successful doctor."

"My mate says the evidence was so convincing that he would have been arrested by now, except that Inspector McDonald refused to do it. He worked with both Mr. Holmes and Dr. Watson, you know." After talking for a few more minutes you return to your lodgings. There, you are amazed to find a note from Mycroft Holmes, brother of the late detective, asking you to visit him at his rooms in Pall Mall. Naturally, you hurry out to answer this summons.

Mycroft himself admits you to his rooms. He is a large, heavily built man. In spite of being much heavier, you can see a strong resemblance between him and his late brother Sherlock. He thanks you for your prompt response, and explains that renovations in his offices have made it necessary for him to take a few days away from his work for the government. He then introduces you to his other guest, Inspector Alec McDonald of Scotland Yard.

"So you want me to look into the Milton murder," you say boldly, hoping to make an impression on the men.

"You may be right, Mr. Holmes," McDonald laughs. "The young man's technique puts me in mind of your brother."

"It was hardly a brilliant deduction," Mycroft answers, "as every newspaper in the city reported that you were the officer in charge of the investigation."

"But why did you want me?" you ask. "If I read the papers correctly, you expect to make an arrest shortly."

"I do, lad, and more's the pity," McDonald answers. "I've looked into the matter as carefully as I can, and all the evidence ties a rope around one neck—and there's the rub."

"Mr. McDonald believes that the evidence points to Dr. John Watson, Sherlock's old friend and comrade," Mycroft interrupts. "I find it difficult to believe he would commit murder, and for the sake of my brother I want the case investigated by an independent pair of eyes. If poor Sherlock were still with us, I'm sure he'd clear the doctor soon enough."

"That may be so," McDonald laughs, "and I wish Mr. Holmes were still in London, for while he showed us our

foolishness often enough, he also seized many a scoundrel. But if you are interested in investigating this matter," he adds, turning to you, "I will give you an outline of the evidence."

"Certainly, sir," you answer. "I understand the killing occurred in 'The Three Continents Club?'"

"Aye, that it did, not two blocks from where we're sitting," the Inspector answers. "There were not many men in the club last night, only a few kept in the city by business. Four of them, Sir Terrence Milton, Dr. Watson, Mr. Christopher Marshall and Mr. Thomas Martin, spent the hours after supper in a game of whist. When Dr. Watson and Mr. Marshall won the decisive rubber with a slam in the last hand, Sir Terrence accused Dr. Watson of cheating, saying he must have learned the finer arts of card playing in his days in the wilds of America and Australia.

"Well, Dr. Watson is no man to take such a suggestion, as you may know, and he shouted at Sir Terrence, accusing him of cheating many a man through his crooked companies. I understand that Dr. Watson lost a considerable sum when Sir Terrence's latest company, the Ivory Coast Mining Venture, failed. The police have been looking closely into that company, since its fall.

"Well, Sir Terrence answered by suggesting that if Dr. Watson had spent less time showing a certain singer the sights of London and more studying the prospectus, he wouldn't have mistaken a high-risk venture for a safe and sound investment—but that was all he said," the Inspector concludes, "for Dr. Watson put his fist between Sir Terrence's eyes at this point and stretched him on the carpet."

"What's that about a woman?" Mycroft asks. "You didn't mention that before."

"I'm sorry, sir, I must have forgotten," McDonald answers. "According to his friend Marshall, Watson has been seeing quite a lot of one of the singers performing at Prism Hall in Piccadilly. Nothing wrong with that, of course. The doctor's wife died more than a year ago."

Mycroft nods heavily. "Sherlock always said that Watson had the expertise where women were concerned. And it's gotten him properly into trouble this time." He thinks a

moment and turns to you. "You must investigate the scene of the crime and interview the witnesses. I have a friend, Captain Locke of the Provost's Office, who is very familiar with the night life of London. I will ask him to investigate this woman. But go on, Inspector McDonald; continue your description of events at the club."

"Thank you. Well, the other members broke up the fight, and a little before nine o'clock Sir Terrence went upstairs. Watson went up a little later and sat in a billiard room to have a drink and settle his temper, or so he says. He left the room about nine-thirty, and a servant went in immediately to fetch the empty glass and tidy things. The servant found Sir Terrence lying in the corner with his head smashed in. He says no one else could have entered the room after Watson left. He ran screaming into the hall, the other members rushed in, and they summoned us. The case looks very clear-cut to me. Watson was the only man in the room, he had just argued with Milton, and he had other reasons to hate Milton, as his bogus company cost the Doctor a good deal of his investment capital. According to Marshall and others, Watson has been having a hard go of it lately, between the death of Mr. Holmes and his wife, and all sorts of financial problems. His medical practice suffered badly while his wife was sick. He has lost his outside income as he can no longer write about Mr. Holmes."

"Was the weapon Dr. Watson's?" you ask.

"No, anyone in the room could have used it," McDonald answers. "The killer used the poker from the fireplace. The fire had burned low, and it's a little surprising that Watson didn't look for the poker to stir it up. But less surprising if he had just used the poker to kill a man!"

"And what does Dr. Watson say he was doing in the room for the half hour he was there?"

"He says he just sat by the fire, drank his brandy and read a newspaper," McDonald answers. "He claims that he was shocked to realize that there was a dead man in the corner for the entire period of time."

You nod, trying to think of holes in this argument.

- If you ask McDonald more questions, turn to 159.
- Otherwise, turn to 443.

"Well," the Inspector answers grimly, "It shall be the rope for Mr. Marshall then. When I heard what happened to you,

I went to see Symington myself. He was dead, shot through the head. I shall get some men and see if I can bring Marshall to justice. You rest yourself, and let your poor head heal up. That was a brutal blow you took." As the police detective leaves, you lie back and try to relax. While you haven't failed completely in this investigation, you certainly haven't succeeded.

- *If you begin the case again, turn to the Prologue.*
- *If you would like the case explained, turn to 435.*

A few necessary errands fill the rest of the morning. At noon you stop at your lodgings to check your mail. Amid the bills and personal letters there is a note from Mycroft Holmes, asking you to visit him at home immediately. You wonder whether he has made some crucial discovery in the case and hurry to his lodgings to see him.

Mycroft greets you with his customary politeness. "Thank you for coming promptly," he says, leading you into a small study. "Captain Locke succeeded in his investigations of the lady's background, and I thought you would like to hear his report."

As you nod in agreement, another man enters the room, dressed in a uniform trimmed in the fashion of the provost department. He is a tall lean man, with bushy, greying sideburns, a thick mustache and heavy eyebrows. The tinted glasses that hide his eyes are almost hidden among all the hair.

"This is Captain Locke," Mycroft announces. "The army very kindly loaned his services to me, and he has carried out his part of the case very quickly indeed."

"What did you find out about the lady?" you ask.

Locke consults some notes and begins to speak in a soft, almost toneless voice. "The lady is a singer named Miss Ellen Phipps, who is now performing at the Prism Hall. Everyone who knows her speaks well of her. She is engaged to be married as soon as she completes her current series of performances. Her relations with Watson were of the most innocent kind."

"They were?" you ask in surprise. "Some of the men who talked about it believed that the Doctor was likely to marry her."

"There is no evidence of that," Locke answers. "If you review the evidence carefully, you will trace all those stories to one source.
